Effective January 1, 2013, when registering a vehicle or renewing^ tags you must bring your insurance cards for^ all vehicles and^ the drivers license number and expiration date of all parties on the registration.

## REGISTERING A NEWLY ACQUIRED VEHICLE

When purchasing a tag for a newly acquired vehicle, you must come into our office and register the vehicle within 20 days from the date of purchase. If purchased from an individual or an out of state dealer, sales tax will be due on the purchase price of the vehicle.
